ECOGRO WS 8-0-0 is a plant derived nutrient recommended for Organic and Conventional fertilization programs.

ECOGRO WS 8-0-0 can be used for aerial, foliar and chemigation based applications in crops.

DIRECTIONS FOR USE

Shake very well before use.

ECOGRO WS 8-0-0 can be applied to all agricultural and horticultural crops including vegetables, fruit trees, nut trees, row crops, feed and forage crops.

Crop Foliar Rates: Apply 1-5 Quarts per acre. Multiple applications may be made at 7-14 day intervals.

Crop Sprinkler & Drip Rates: Apply 1-10 Quarts/ acre.

Aerial Use Rate: Apply 1-10 Quarts/acre.

Use rates suggested as a guideline only. Exact use rates should be determined based on regions, crops and stages.

Storage: Store in the original container in a cool, dry place away from excessive moisture and heat. Recap container after each use.

Caution: May be harmful if swallowed. Avoid contact with eyes. Do not inhale spray mist. Wash hands after use. For general cleaning, use warm soap water.
